LLP (Grant Thornton), Chartered Accountants (Firm Registration No.001076N/N500013) for a period of 5 years commencing from the conclusion of 13th Annual General Meeting (AGM) till the conclusion of 18th AGM of the Company.

However, as per the recent Reserve Bank of India Guidelines Ref. No. DoS. CO.ARG/ SEC.01/08.91. 001/2021-22 dated April 27, 2021, on Appointment of Statutory Auditors, M/s Walker Chandiok & Co. LLP, Statutory Auditors of the Company have communicated their ineligibility to continue their engagement with the Company on the grounds that the aforesaid

guidelines prescribe that a firm cannot conduct statutory audit of more than 8 NBFCs. Therefore, the Company had to explore other firms that qualify the eligibility criteria laid down by the guidelines.

- 2. Increase in the borrowing power of the Company U/s 180(1) (c) of the Companies Act, 2013, not exceeding an amount of Rs.12,000 Crores (Rupees Twelve Thousand Crores Only)
- 3. Re-appointment of Mr. D R Dogra (DIN: 00226775) as Independent Director of the Company for a second term of 5 consecutive years with effect from September 08, 2021
- 4. Appointment of Mr. Harshan Kollara (DIN: 01519810) as Independent Director
